Evaluation will be done slice by slice basis, with contracts awarded based on the award combination that is of least cost to the Purchaser.]

5. Sealed or Electronic bids must be submitted to the office Dharmadevi Municipality Sankhuwasabha Shankhuwasava Province One Nepal through PPMO website www.bolpatra.gov.np. on or before 02-05-2022 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 02-05-2022 13:00 hours at the office of Dharmadevi Municipality Sankhuwasabha Shankhuwasava Province One Nepal
Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 30000.0NRs which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
