5. Sealed or electronic bids must be submitted to the office Dharmadevi Municipality, Sankhuwasabha, Koshi Pradesh, Nepal by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 18-03-2025 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 18-03-2025 13:00 at the office of Dharmadevi Municipality, Sankhuwasabha Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
